Mayor Sobel called the meeting to order at 7:00 p.m. and stated that notice of this meeting has been posted and published in compliance with the Open Public Meetings Act.

Award of Contract for Water Materials for Maintenance and Repair: Bids were received by the Township Manager on June 6, 2006 for aforementioned project. In a memo dated June 20, 2006, James Lauro, Public Works Director recommends a contract be awarded to The Lee Company, Items 1,,8,9,10,11,12,13,16,17,18,19,20,21,43,44,57,58,59,60,61,62,71,72; Water Works Supply Items 3,4,5,6,7,14,15,22,23,35,36,37,38,39,40,41,42,51,52,63,64,65,66,67,68,69,70 and National Water Works, Items 24,25,26,27,28,29,30,31,32,33,34,53,54,55,56. A straw poll vote was unanimously in favor of bringing this resolution to tonight's public meeting.

Award of Contract for Road Materials for Maintenance and Repair: Bids were received by the Township Manager on June 8, 2006 for aforementioned project. In a memo dated June 29, 2006, James Lauro, Public Works Director recommends a contract be awarded to Stavola, Items 1,2, 3A,4,4A,5,5A; Trap Rock for Items 3 and C.J. Hesse for Items 6 and 6A. A straw poll vote was unanimously in favor of bringing this resolution to tonight's public meeting.

Stormwater Management Plan: This ordinance adopts our new Stormwater Management Plan which is a new requirement under the new stormwater regulations. A straw poll vote was unanimously in favor of introducing this ordinance at tonight's public meeting.

Bond Sale: Resolution No. 2006-94 and Resolution No. 2006-95 authorizes a bond sale of \$9,016,000 general improvement bonds. Steve Rogut and Tom Fallon were present for any questions that need to be answered. A straw poll vote was unanimously in favor of bringing these resolutions to tonight's public meeting.

Councilman Raymond made a motion to adjourn, seconded by Councilman Minutolo and unanimously concurred by Council.
