

RESOLUTION NO. 2007-78

BE IT FURTHER RESOLVED that the following conditions be annotated on License #1330-33-011-011:

1. Management shall provide security and lighting outside the establishment to prevent disorderly behavior.
2. Management shall provide security upstairs to check identification of patrons as follows:
 - Friday and Saturday evenings from 9:00 p.m. until closing during the months from September through June.
 - Every evening from 9:00 p.m. until closing during the months of July and August.
 - Management shall designate pool tables in the rear for use by those under the age of 21.
 - Management shall restrict patrons under the age of 17 from the premises after 11:00 p.m. on weekdays and after 12:00 midnight on Friday and Saturday evenings.
