Please be advised that at the request of Lombardo Construction, we have reviewed our files relative to the release of the performance guarantees and we are reporting herein.

**SITE IMPROVEMENTS**

Concerning performance guarantees, we understand that the cost estimate for Schedule A improvements (off-site and contributory) was \$7,800.00 therefore, the applicant was required to post 10% (\$780.00) of the total performance guarantee in cash and 90% (\$7,020.00) of the guarantee in a form of surety acceptable to the Township.

It is our understanding that the performance guarantees posted for this site remain at 100% of the original amount.

Relative to our recent observation of the site and review of our files, the improvements have been completed.

Accordingly, we recommend a release of the performance guarantees for 171 Orchard Street at this time subject to the payment of all outstanding escrow fees, if any.
