

ORDINANCE NO. 6-2017

ORDINANCE REAPPROPRIATING \$360,000 PROCEEDS
OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL
PURPOSES IN ORDER TO PROVIDE FOR
IMPROVEMENTS TO PARKS AND PLAYGROUNDS IN
AND BY THE TOWNSHIP OF ABERDEEN, IN THE
COUNTY OF MONMOUTH, NEW JERSEY.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
ABERDEEN, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of
all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$235,000 of the
proceeds of obligations originally made available pursuant to Section 3(b) of Bond Ordinance #5-
2014, finally adopted June 17, 2014, of the Township of Aberdeen, in the County of Monmouth,
New Jersey (the "Township") and \$112,500 of the proceeds of the obligations, along with the
\$12,500 down payment which has not been spent, originally made available pursuant to Section
3(d) of Bond Ordinance #15-2016, finally adopted June 21, 2016, of the Township are no longer
necessary for the various purposes for which the obligations previously were authorized:

Section 3(d) of Bond Ordinance #15-2016	The acquisition and installation of fences, playground structures and a rubber surface, including all work and materials necessary therefor and incidental thereto, finally adopted June 21, 2016	\$125,000

Section 2. The \$360,000 described in Section 1 and made available pursuant to N.J.S.A. 40A:2-39 is hereby reappropriated to provide for improvements to Deerfield Park and playground and Midland Park and playground, including all work and materials necessary therefor and incidental thereto.

Section 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
