BE IT FURTHER RESOLVED that the reduction of the aforesaid bond is subject to the payment of any outstanding inspection and professional fees and concurrence by the Township Manager and Township Attorney.

Dear Ms. Ventura:

As per the Developer's request, we have reviewed the installation of those items as covered by a performance guarantee for the above referenced project. As per Section 902 of the Township Land Development Ordinance, the Applicant is required to post a guarantee for off-site (Schedule A) and on-site (Schedule B) improvements.

The cost estimate for Schedule A improvements (off-site and contributory) was \$7,982.40 to cover the cost of curbing and sidewalk in front of the subject development lots. The Developer has completed all of those improvements as required in front of Lot 11.01; therefore, the Applicant is requesting a reduction of the total performance guarantee in an amount equal to \$4,740.00. The remaining amount of \$3,242.40 will continue to be held by the Township until such time as the improvements in front of Lot 12.01 are completed.

All of the work in front of Lot 11.01 has been complete in accordance with the Township standards and has been in place for longer than the required two year maintenance guarantee. Accordingly, we can recommend that the \$4,740.00 be returned to the applicant, Mr. Dennis Bruno.
