

**RESOLUTION NO. 2016-101**

**WHEREAS**, the Keyport Bayfront Business Cooperative has requested the use of Aberdeen Township Public Works property at Matawan/Cliffwood Point across the harbor from the Keyport waterfront in the Township of Aberdeen as a launch site for a fireworks display on October 8, 2016; and

**WHEREAS**, the Township of Aberdeen has traditionally granted such permission, upon submission of a “hold harmless agreement”, evidence of adequate insurance and approval from Fire District #2.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Aberdeen that the Keyport Bayfront Business Cooperative is hereby granted permission to use the above referenced property as a launch site for their fireworks display, subject to approval of the above conditions.

**BE IT FURTHER RESOLVED** that any fireworks permit issued by Fire District #2 shall expire on 1:00 a.m. on October 9, 2016.
